



Aligning expectations between supervisors and doctoral candidates

Dear supervisor, dear prospective doctoral candidate,

You are about to embark on a supervisory relationship that will last several years and forms the basis for successfully completing the proposed doctoral thesis project. At the start of this journey, we recommend that you discuss your **expectations** to ensure that you both have a clear understanding of the planned doctoral thesis project. You can use this questionnaire as a basis for the discussion.

How to use the questionnaire:

- The supervisor(s) and the doctoral candidate **set up a meeting**.
- Before the meeting, the supervisor(s) and candidate **complete the questionnaire individually**.
- During the meeting, the supervisor(s) and the candidate **discuss the responses** and find common ground suitable for the doctoral thesis project.

1. Supervisory meetings

How frequently will the supervisor and the candidate hold individual meetings to discuss the doctoral thesis project?

How often will the supervisor and the candidate meet in team meetings (e.g. research group meetings, departmental seminars)?

Will individual meetings be mostly online or in-person?

Who is going to prepare which documents before and after a meeting (paper drafts, agenda, protocol, etc.)?

2. Time management

When can the candidate expect a response after contacting the supervisor by email, and vice versa?
What is a reasonable time frame for receiving feedback on texts from the supervisor?
When should the candidate complete the public presentation at the faculty?
How many hours per week should / will the candidate work on their doctoral thesis on average?
How many years do you think it will take to complete the doctoral thesis?
In case of employment at the University of Vienna: What are major milestones expected to be completed for prolonging the contract, if it includes a probationary period?

3. Training, research and dissemination
